Artist's statement: Barristers are the chameleons of the courtroom. Their black robes and horsehair wigs are their camouflage. In their private lives, these professional advocates are as varied as anyone in their habits and personalities. This exhibition is my view of the Bar, from the inside looking out. Barristers are almost never photographed in their work environment and are rarely photographed in their professional robes except for formal portraits on ceremonial occasions. As an insider, and a photographer, I have had unparalleled access to this group of legal specialists. Most of my subjects are criminal law barristers who conduct criminal jury trials, either as prosecutors or for the defence. They range from eminent, senior members of the profession who have a high public profile to junior barristers. The hobbies, interests and activities they pursue are as varied as you would find in any section of the community. The barristers I have photographed are vibrant, grounded people, with active lives outside of the law. I hope to have shown that inside the professional robes there are often people with humanity and a good sense of humour.

Mark Tedeschi has been a keen photographer since 1988. He has had ten solo exhibitions and numerous joint exhibitions, both in Australia and overseas. His photographs are included in the collections of the Art Gallery of New South Wales, the National Library of Australia, the State Library of New South Wales, the Museum of Sydney and the Justice & Police Museum. His images have been published in many books and journals and he has won many photographic prizes and awards in Australia and overseas. Mark is also the Senior Crown Prosecutor for New South Wales.

The images in this collection were exhibited at the Justice and Police Museum in Sydney from 29th March-27th April 2008.
